WHAT ARE AND WHAT COOKIES ARE FOR

Cookies are information (small text strings) created by a server that are entered on your browser when you visit a website.

Cookies perform different and important functions within the network (i.e. implementation of computer authentication, monitoring of sessions, storage of information on specific configurations concerning users accessing the server, storing preferences).

TYPES OF COOKIES USED BY THIS SITE

Technical cookies

These cookies are necessary for the proper functioning of the site. Allow browsing of pages and search for other services. Without these cookies we could not provide the services for which users access the site.

All technical cookies do not require consent, but only the obligation to inform, so they are installed automatically when accessing the site.

They are not used for other purposes and are normally installed directly by the owner or operator of the website. They can be divided into:

- Navigation or session cookies, which guarantee the normal navigation and use of the website; they are in fact necessary for the proper functioning of the site.
- Functionality cookies, which allow the user to navigate according to a series of selected criteria (for example, the language, the products selected for purchase) in order to improve the service provided.

All technical cookies do not require consent, but only the obligation to inform, so they are installed automatically when accessing the site.

Third-party cookies

The site uses Google Analytics for statistical purposes. It is a web analysis service provided by Google Inc. ("Google") that uses cookies that are stored on the user's computer to allow statistical analysis in aggregate form in order to use the website

visited.

FIELD OF COMMUNICATION OF PERSONAL DATA

The data provided will not under any circumstances be disseminated. However, such data may be disclosed:

1. to companies that provide site maintenance services;

3. to subjects of public security and to other public and private subjects for the fulfillment of obligations foreseen by the law.

The processing of data will be carried out by employees of the Controller specifically identified by those responsible for processing.

PROCESSING METHODS

Data can be processed using computer, paper, digital, electronic, magnetic and automated tools. The collected data will be stored and stored at Rotair S.p.A. in Caraglio (CN), Via Bernezzo 67. The data collected will be processed exclusively for the aforementioned purposes.

LEGAL BASIS OF TREATMENT

The legal basis of the processing is the request to browse the site for technical cookies

DURATION OF COOKIES

Some cookies (session cookies) remain active only until the browser is closed or when the logout command is executed. Other cookies "survive" when the browser is closed and are also available in subsequent visits by the user. These cookies are called persistent and their duration is set by the server when they are created.

RIGHTS OF THE INTERESTED PARTY

The subjects to whom the personal data refer have the right at any time to obtain confirmation that personal data are being processed or not, and in this case, to obtain access to the data and information referred to in 'art. 15 of the Regulations, to obtain a copy of such data or the related rectification (articles 15 and 16 of the Regulations).

Furthermore, the interested parties have the right to request the deletion, the limitation on processing, the portability of data and to propose a complaint to the supervisory authority and to oppose in any case, for legitimate reasons, their processing (article 17 of the Regulations).
