Legal basis of the processing

Data retention

Mandatory / optional nature of providing data

The provision of data is optional. The refusal to provide data makes it impossible to obtain the newsletter service.

Communication and dissemination of data

Personal data collected for the purposes indicated above will not be disseminated.

Personal data may come to the knowledge of a third-party company located in non-EU countries that manage the Company's website. The transfer of your data will be protected in compliance with the Standard Contractual Clauses required by Regulation (EU) 2016/679 and applicable regulations.

In case of need, for activities related to the maintenance of the technological part of the site, the data related to the newsletter service can be processed by subjects in charge of maintenance.

Personal data may be accessed by authorized employees of the company.
