

Privacy notice to the customers pursuant to the article no. 13 of the European Regulation (EU) 2016/679 and of the current relevant legislation

According to the article no. 13 of the European Regulation (EU) 2016/679 (hereinafter referred to as "Regulation") and of the current relevant legislation, **ROTAIR S.p.A.** (hereinafter referred to as "Company"), acting as Data Controller, informs you that the personal data you provide will be treated in a relevant and transparent manner and in compliance with the principles of lawfulness and necessity in accordance with the applicable provisions in force.

Purpose of the Processing and mandatory provision of data

In this regard, we inform you that the processing of your personal data will be for purposes related or instrumental to the activity of our Company, and therefore for:

- a) perform the obligations related to the conclusion of the contract. The conferment of data is mandatory as it is necessary for the exact execution of contractual and pre-contractual obligations and their failure to provide it makes it impossible to complete the fulfillment of contractual obligations to be paid by the Company;
- b) comply with legal, accounting and administrative obligations; The provision of data is mandatory as necessary for the exact execution of the legal obligations and their failure to provide it makes it impossible for the Company to comply with legal obligations
- c) for purposes related to the promotion and sale of products of the Company (so-called marketing). The provision of data is optional. The refusal to provide data implies the impossibility for the Company to use your data for marketing purposes.

Methods for data processing

Personal data will be processed using paper, computerized or electronic means and with adequate security measures to guarantee the security and confidentiality of your personal data in compliance with the provisions of current legislation.

Legal basis of the processing

The legal basis of data processing is given by the contractual relationship, the law and the consent.

Data retention

In compliance with the principles of proportionality and necessity, the data will be kept for the time necessary to fulfill the aforementioned purposes, unless required by law

Communication and dissemination of data

Personal data collected for the purposes indicated above will not be disclosed. However, the data will be communicated by the Company in the following terms:

- to public and private subjects, who can access the data by virtue of the provision of law, regulation or community legislation, within the limits set by these rules;
- to our consultants and other professionals within the limits necessary to carry out their duties;
- to the Holding Company, with registered office in India.

The data may be accessed by the authorized employees of the Company.

Data may be transferred to a third country.

The transfer of your data will be protected in compliance with the Standard Contractual Clauses required by Regulation (EU) 2016/679 and applicable regulations.

Rights of the interested party

The subjects to whom the personal data refer have the right at any time to obtain confirmation of the existence or otherwise of the same data and to know its content and origin, verify its accuracy or request its integration or updating, or rectification (articles 15 and 16 of the Regulations).

Furthermore, the interested parties have the right to request the deletion, the

limitation on processing, the portability of data and to propose a complaint to the supervisory authority and to oppose in any case, for legitimate reasons, their processing (article 17 of the Regulations).
