

Privacy notice to the suppliers pursuant to the article no. 13 of the European Regulation (EU) 2016/679 and of the current relevant legislation

According to the article no. 13 of the European Regulation (EU) 2016/679 (*hereinafter referred to as "Regulation"*) and of the current relevant legislation, **ROTAIR S.p.A.** (*hereinafter referred to as "Company"*), acting as Data Controller, provides some information about the processing of personal data provided during the supply of products / services.

Purpose of the Processing

The personal data provided by the suppliers are processed exclusively for purposes strictly connected to perform the contractual obligations and to fulfill specific requests of the supplier, as well as to fulfill regulatory obligations, in particular accounting and tax.

Methods for data processing

Personal data will be processed using paper, computerized or electronic means and with adequate security measures to guarantee the security and confidentiality of your personal data in compliance with the provisions of current legislation.

Legal basis of the processing

The legal basis of data processing is given by the specific contractual relationship established

Data retention

In compliance with the principles of proportionality and necessity, the data will be kept for the time necessary to fulfill the aforementioned purposes, unless required by law

Obligation to provide data

The conferment of data is optional but necessary for the exact execution of the contractual and pre-contractual obligations and their failure to indicate implies the impossibility of completing in an exact manner the fulfillment of the contractual obligations borne by the Company.

Communication and dissemination of data

Personal data collected for the purposes indicated above will not be disclosed. However, the data will be communicated by the Company in the following terms:

- to public and private subjects, who can access the data by virtue of the provision of law, regulation or community legislation, within the limits set by these rules;
- to our consultants and other professionals within the limits necessary to carry out their duties;
- to the Holding Company, with registered office in India.

The data may be accessed by the authorized employees of the Company.

Data may be transferred to a third country. The transfer of your data will be protected in compliance with the Standard Contractual Clauses required by Regulation (EU) 2016/679 and applicable regulations.

Rights of the interested party

The subjects to whom the personal data refer have the right at any time to obtain confirmation that personal data are being processed or not, and in this case, to obtain access to the data and information referred to in 'art. 15 of the Regulations, to obtain a copy of such data or the related rectification (articles 15 and 16 of the Regulations).

Furthermore, the interested parties have the right to request the deletion, the limitation on processing, the portability of data and to propose a complaint to the supervisory authority and to oppose in any case, for legitimate reasons, their processing (article 17 of the Regulations).
